### RP Rendite Plus – Allianz Vermögenskonzept Defensiv

Fund merger of Allianz Horizont Fonds – Allianz Horizont Defensiv into RP Rendite Plus – Allianz Vermögenskonzept Defensiv

Dear Shareholder,

You are holding shares in the **RP Rendite Plus – Allianz Vermögenskonzept Defensiv** fund in your securities account.

The Management Company of the **Allianz Horizont Fonds – Allianz Horizont Defensiv** fund, Allianz Global Investors Luxembourg S.A., and the Board of Directors of RP Rendite Plus - Société d'Investissement à Capital Variable (the "Company") have decided to merge the **Allianz Horizont Fonds – Allianz Horizont Defensiv** fund with **Allianz Vermögenskonzept Defensiv**, a subfund of RP Rendite Plus, as shown in the table below, with effect from **27 March 2014** (the "Merger Date").

The statutory disclosure of the fund merger to investors who are resident in Germany was published in the *Börsenzeitung* on 13 February 2014.

The fund merger does not give rise to any significant financial changes for investors in RP Rendite Plus – Allianz Vermögenskonzept Defensiv.

### Why are the funds being merged?

The funds being merged are similar with regard to their risk/return profile and investment objective. Merging them will enable fund management to implement the investment strategy with a greater volume. As a result, it will be possible to pursue market opportunities even more extensively and flexibly, which is in the interest of the unitholders.

### Impact on RP Rendite Plus – Allianz Vermögenskonzept Defensiv

The assets under management will increase as a result of the merger, enabling more efficient use of fund management resources. The risk profile and investment objectives remain unchanged.

### How the merger of the funds will be carried out

On the Merger Date, shares in RP Rendite Plus – Allianz Vermögenskonzept Defensiv will be credited to investors in Allianz Horizont Fonds – Allianz Horizont Defensiv. In return, RP Rendite Plus – Allianz Vermögenskonzept Defensiv receives the assets and liabilities of Allianz Horizont Fonds - Allianz Horizont Defensiv. There is no change to the investment structure of
